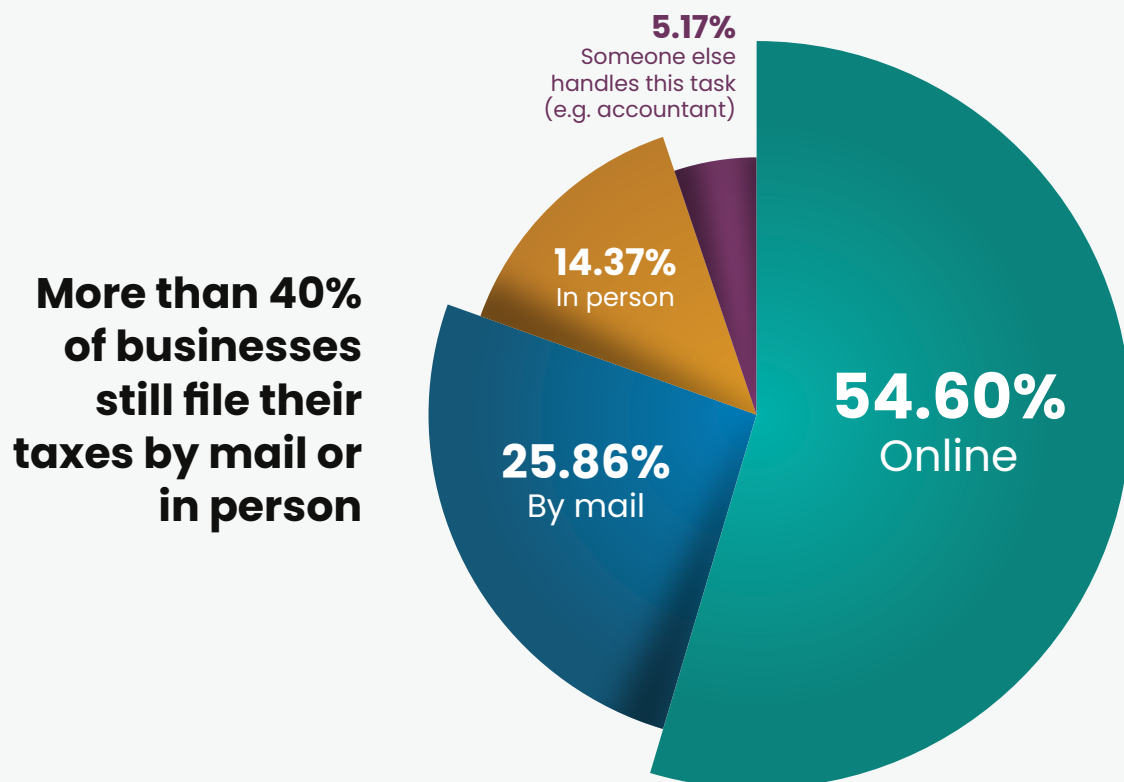

For local governments, the paperless remittance of online filing systems can save critical space, upgrade security, and **reduce paper processing by 95%**. It also allows customer service representatives to address errors and resolve issues faster, rather than having to allocate time to the manual input of paper documentation.

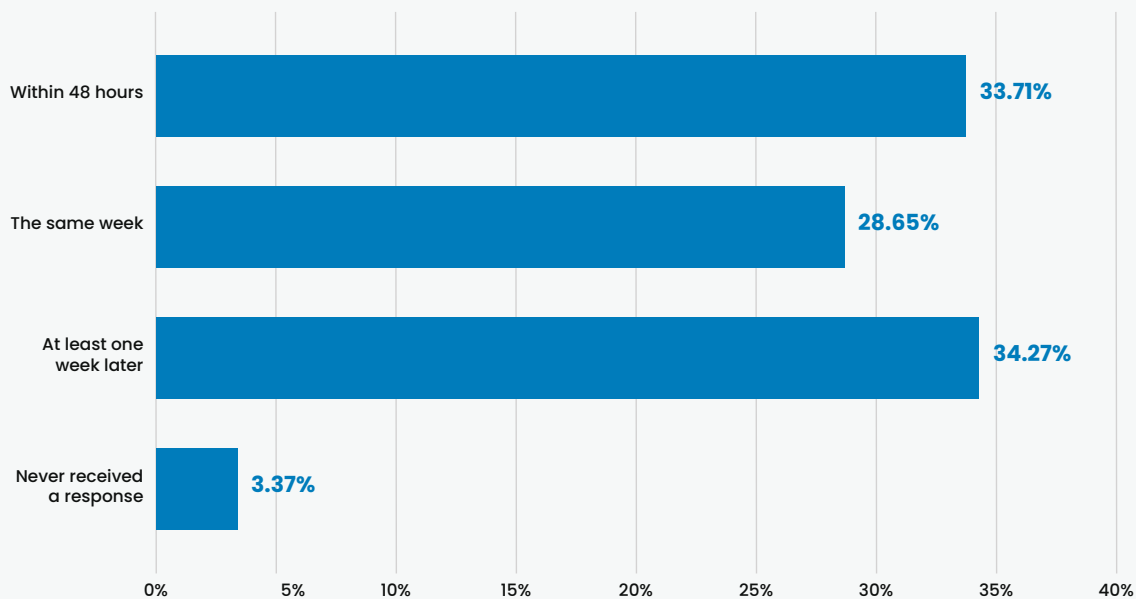

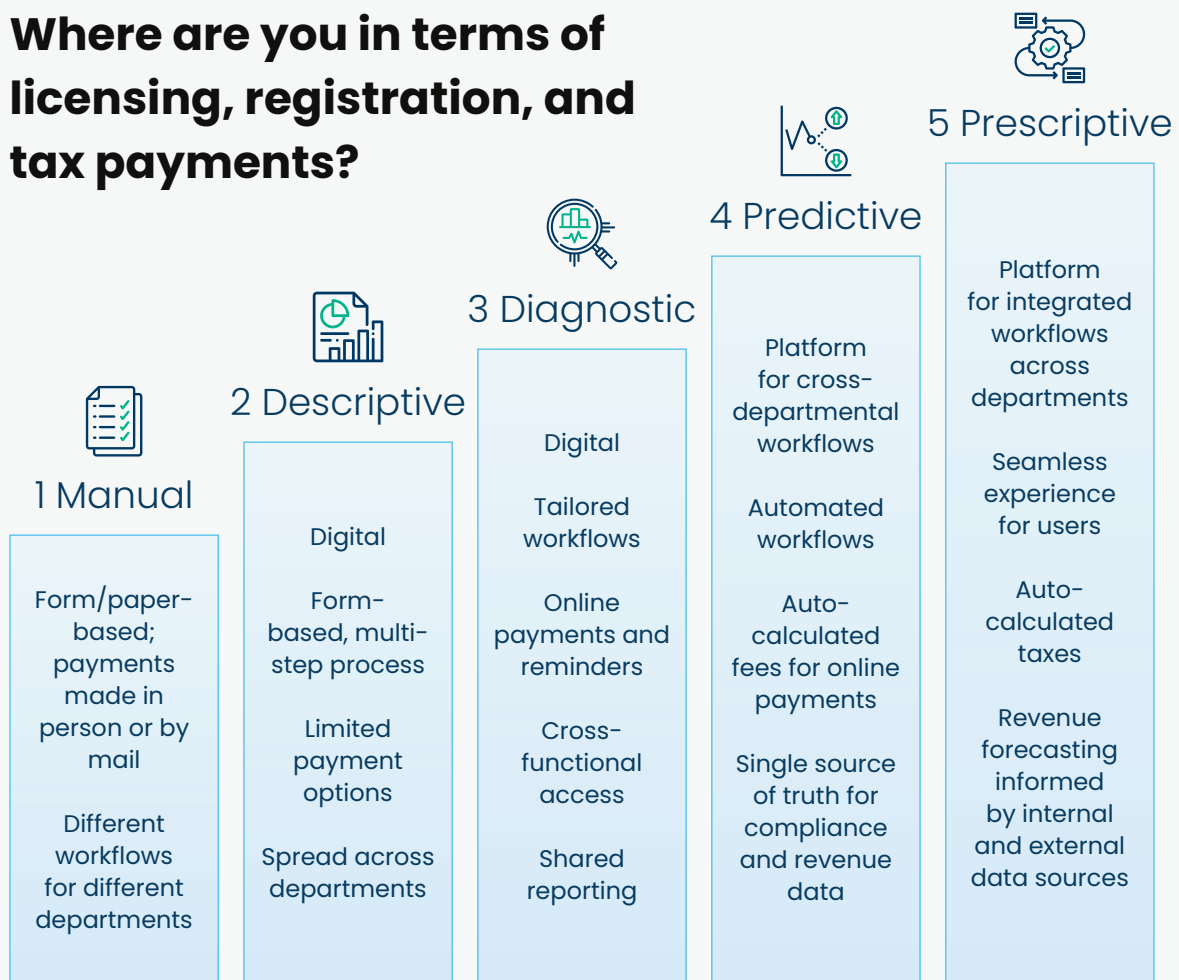
