



# **A Turning Point** for Local Governments

During the height of the COVID-19 pandemic, stories that captured the chaos and uncertainty of the time were echoed by couples nationwide.

- One couple in Kentucky drove more than 20 miles to a neighboring county in search of a marriage license, only to discover licenses were restricted to local residents—this after the courthouse just a mile from their home had shut its doors.
- Las Vegas, known for its iconic Little White Chapel and non-stop weddings, suspended all marriage licensing for 30 days.
- A Massachusetts bride made calls to four different town halls, each time being turned away as they had ceased issuing marriage licenses.

The lack of access to essential services not only added significant stress but also piled on the logistical challenges for couples eager to tie the knot.

It became clear that transitioning to a remote marriage licensing process would not only streamline one of the most crucial steps of the process but also make it more accessible for couples across the country.

# **Introduction to Remote Marriage Licensing Software for Government**

## **What Are Remote Marriage Licensing Services?**

Now, thanks to digital solutions, couples can complete the entire process online—from application and identity authentication to saying their oaths via video conferencing and receiving their marriage license.

This change fits well with the ongoing move toward digital services in government and meets the public's expectations for convenience, efficiency, and easy access.

## The Rising Demand for Remote **Marriage Services**

The pandemic <u>accelerated many changes</u> that were already starting to happen in government services. Due to lockdowns and social distancing, there was a push to develop remote options for services usually requiring in-person interactions.

Marriage licensing experienced a meteoric rise in demand for remote options. This demand, along with the need to keep legal processes for marriages going, quickly led to the creation and use of online systems for marriage licensing.

Even though the pandemic has since faded from the public discourse, the need for remote services remains urgent, and local governments must quickly find more lasting solutions.

Continuing to enhance and adapt the marriage licensing process will ensure it meets ongoing demands for efficient and accessible government services, well into the future.





# Local Governments Using Online Marriage Licensing Software

Local governments across the country are increasingly adopting online marriage licensing software to enhance service offerings. Here's a look at how some agencies have successfully implemented systems—improving service delivery, customer satisfaction, and operational efficiency.

While many states have embraced the convenience of online marriage licensing, the extent to which the process can be conducted remotely varies according to state laws.

For instance, states like Michigan allow most steps of the marriage licensing process to be completed online, but still require couples to present identification in person. This means that although the initial application and other steps may be handled digitally, final verification steps may necessitate a physical presence.

It's important to help couples understand that the specifics of what can be completed online versus what must be done in person are determined by individual state regulations.





Dauphin County, Pennsylvania faced the challenge of continuing to offer essential services without a physical office after a state mandate required office closures during the pandemic.

Initially, the Register of Wills & Clerk of Orphans' Court and her First Deputy developed a system using GovOS technology for online forms combined with available video technology to carry out some of the work online.

Later, GovOS partnered with the County to integrate a scheduler platform and added automated workflows, so communication between couples and the office was faster and more efficient.

The impact was immediately clear–Dauphin County received 475 marriage license application submissions in the first 4 months and issued 347 licenses. The following year, the County reported a total of **2,100 marriage** license applications—about 86% of all applications received-were submitted online.

Calhoun County, Michigan also embraced the shift toward digital by implementing remote marriage licensing software. Initially, marriage licensing was a labor-intensive process that took around 45-60 minutes per application, requiring in-person visits and handling of paper forms prone to errors.

The introduction of the GovOS system allowed couples to submit applications and fees online, reducing processing times dramatically to just 20 minutes.

Although the final step is still required by state law to take place in-person, the new system has enhanced readability of applications, saved costs on paper, and been well-received by the public, garnering hundreds of applications that account for more than a third of the County's marriage licenses.

Tarrant County, Texas was the first public agency in Texas to implement remote marriage licensing software. As the third largest county in Texas, Tarrant processes around 1,500 marriage license applications per month.

Traditionally, obtaining a marriage license involved a time-consuming process where applicants filled out paper forms, waited in line, and had clerks manually reenter the information.

This method typically took 25-30 minutes per application, and required all hands on deck due to the heavy usage in the vital records office. The County sought to reduce the time to process an application down to 10-15 minutes with the GovOS system.

This efficiency not only frees up senior staff for other projects but also enhances service delivery, making Tarrant County a pioneer in Texas for adopting this advanced technology.
